



We operate across a multitude of sectors, working multi-nationals, building facade and security subcontractors - to name but a few.




QUALITY PRODUCTS AND SERVICES.

In addition, Royal Boon Edam International B.V, our Group Head Office based in Holland, is an ISO 9001:2015 accredited company. The company is committed to total quality in all areas and employs a dedicated Product Quality & Health and Safety Manager.

All installations, once completed, must be signed off with an internal quality checklist. The company operates a strict Non Conformance Report procedure with all of its suppliers. Any remedial work is quickly followed up by the dedicated Project Manger responsible.

Similarly, Regional Service Managers perform random checks on the standard of our service technician's work being performed on equipment under warranty or maintenance agreement. We are willing to adopt a customer's quality management system as long as it does not compromise the ideology behind our group quality philosophy and is of mutual benefit




OUR **RESPONSIBILITY.**

As a family company, we find it important that our children and their children get a chance to continue our work. We are proud to be the global market leader for the most environmentally friendly entry solution available: the revolving door. But this position also gives us the responsibility to take our sustainability efforts further.



LESS IS MORE

Wherever possible we use recycled or recyclable materials to manufacture our entry solutions. Any waste materials are collected and recycled or disposed of by the most environmentally friendly method available. Among other efforts, we have introduced a new technique for our powder coating facilities using Zirconium. This process provides the same qualitative results with far less impact on the earth. Whereas the waste materials of the traditional powder coating process would have to be disposed of with great care, this new technique allows for the waste to be disposed of directly through the sewer after Ph-testing without any harmful effects on the environment.









SAFETY AND COMPLIANCE

Building regulations, safety guidelines and accessibility requirements differ in each country. Our experts are fully up-to-date on the latest changes regarding your UK regulations and can provide advice and support when integrating these issues with the design and purpose of an entry.


WORKING IT OUT

TRAINING

All site operatives on joining Boon Edam receive induction training; this covers the safety procedures put in place by Boon Edam for safe site working, an overview of current legislation, annual handling and the safe use of chemical products.

Specialist training is also provided in the use of abrasive wheels, the construction of mobile access towers, first aid and driver training. Managers receive training in current legislation and the responsibilities placed on them by this legislation. We have recently implemented a programme of training operated by Human Focus to help further develop and broaden our employee's awareness of health and safety.

PRODUCTS

Due to the size and complexity of revolving doors, the training given for their installation service and repair is mainly carried out on-site, the training is given by experienced, competent installation or maintenance team leaders. Training is also supplemented by attendance at the Boon Edam manufacturing facility in Holland, where more specialised training is given in product working principles and the commissioning of products.

We are fully certified for BS OHAS 45001 and have in place an approved Health and Safety Management System. This accreditation further supports our commitment to health and safety in all we do, whilst assisting in and monitoring the ongoing improvements to our processes.


CSCS

All site operatives hold CSCS cards, all managers who are responsible for liaising with principle contractors and organising installation sites prior to operative's attendance hold CSCS cards, it is the intention of Boon Edam that all new employees are given the appropriate safety training to enable them to become cardholders. Project managers hold the SMSTS certification and all supervisory site engineers have attained the SSSTS certification.

All site operatives who commission and service automatic door products are required to achieve authorised technician status. Investment in staff training is provided at all levels, and all departments, from Information Technology to Finance, Sales to Stores.




